### **Awaken the Workplace: Passion, Purpose & Productivity** – Darrell Scott, Rachel's Challenge

This presentation is the award winning business staff training program designed to implement life changing Rachel's Challenge principles into the business environment and community. It is based on the premise that employees and management personnel will be more productive when they discover their personal passion for fulfilling their purpose in all of their life endeavors. The presentation starts with the story of Rachel Scott who was the first student killed at Columbine High School in 1999. Her story that has been presented to more than 22 million people has transformed businesses, schools and communities with a simple but profound message of starting a chain reaction of kindness and compassion. Your employees will be captivated by the story of a 17 year-old girl whose small acts of kindness and compassion forever changed the lives of those she touched. Rachel's story, set against the backdrop of the Columbine tragedy, is one that produces an intensely personal, reflective experience; an awakening of the innate desire to discover one's purpose; a desire for positive change; and the passion to take immediate action. The program has resulted in national awards for participating companies. With the goal of a positive transformation of your workplace culture, the Awaken event provides interactive training for all employees customized to start a chain reaction of kindness and compassion throughout your organization and it helps create strategies for implementation and sustaining the principles discovered in all the employee Awaken activities.

Review of the 2015 Legislative Session with a look forward to anticipated issues in the 2016 session. We will also cover advocacy best-practices for professional associations.

3 hours, Thursday morning, first session

### **HIGH IN PLAIN SIGHT: Current Alcohol, Drug and Concealment Trends and Identifiers** – Jermaine Galloway (Tall Copy Says Stop)

This workshop covers alcohol and drug clothing, alcoholic energy drinks, alcopops, alcohol and drug concealment methods and containers, drug paraphernalia, drug related music and groups, logos, stickers, new technology, youth party tendencies, party games, non-traditional alcoholic beverages, social networking sites, synthetic drugs, OTC drugs, inhalants, concentrates, E-cigarettes and popular party drugs. This session can also cover common stash compartments that can be used to hide weapons inside everyday clothing, containers and other items, along with the relationship between alcohol, drug and violence tendencies.

This session is unique, in that it provides over 120 visual aids for attendees to hold and become familiar with. In today's culture everything is person-specific and has different meanings to different individuals. Meanwhile, certain items have gained popularity in the alcohol and drug scene – which changes every day. Officer Galloway tailors this session to each community that he teaches in, and constantly updates this training to keep up with the current trends. Once in your community, Officer Galloway conducts a community scan spending time walking through many of your local malls, convenience stores and retail stores, identifying popular culture alcohol and other items that promote drug abuse. This allows the community to know what is going on nationally and locally in their own retail stores. For each person to help prevent youth and adult substance abuse, you MUST know what is going on in your community.

6 hours, all day Thursday

### **Communication During Conflict: Using Mediation Every Day in Your Job, at Home and even at Wal-Mart!** – Ronnie Beach

All of us have constructive and destructive ways of handling conflict. Conflict is one of the four certainties of life. Conflict happens! Nations still struggle, families fracture and marriages fail due to ineffective communication and old habits. Mediation skills are helpful in most aspects of daily life. Learn these mediation skills and how to utilize them.

6 hours, all day Thursday – Pending approval from OJA for 6 hours of MEDIATION CEUs

### **Street Gang Awareness: 101** – Jeff Brownlee

Attendees will be provided with general definitions of terms used to describe gang-related functions. Terms that will be discussed include: basic gang types, gang related crimes, gang member criteria, graffiti, and others. National Gangs/History – Attendees will be provided with a brief history of the following major national gangs: Folks, People, Crips, Bloods, Sureno and Norteno. Gang Recruitment - Attendees will be provided with methods used by gangs to recruit new members. Attendees will also view a video of a beat-in and afterwards will discuss various “risk factors” that lead to joining gangs. Local Gangs (KCK) - Attendees will be shown gangs that are active in Kansas City which will create a better understanding as it relates to the “National

Gang/History” section. Additional research will be presented regarding on various gangs that are active in Georgia for comparison discussion. Graffiti Identification (Tagger/Gang/Cost) - Attendees will learn how to identify gang graffiti from tagger graffiti. Attendees will participate in a group exercise where they will learn how to read/decipher and understand the importance of documenting graffiti. The cost of graffiti abatement from the community will be discussed. Warning Signs - Attendees will learn warning signs to watch for that may lead to gang involvement. Note: Attendees will view animations, photos and topic-related videos designed to enhance the lecture portion of the training.

6 hours, all day Thursday

**Motivational Interviewing: Basics for the Probation Officer** - Josh Stimpfle

Participants will learn about the rationale for using Motivational Interviewing in a criminal justice setting, the spirit of Motivational Interviewing and basic Motivational Interviewing techniques.

3 hours, Thursday afternoon

**Sex Trafficking** – Dr. Sharon L. Sullivan, Washburn University

Commercial sex is one of the most misunderstood aspects of Human Trafficking. What is the difference between a prostituted person, a prostitute and a sex worker? This presentation describes the realities of commercial sexual exploitation in the U.S. It will examine complex trauma and the trauma bond, supply and demand, strategies to help people in prostitution and ways to reduce sex trafficking.

3 hours, Thursday afternoon

**The Legalization Landscape: What Law Enforcement Needs to Know** –Monte Stiles

The latest information regarding drug legalization will be provided, including: the history of drug legalization; the identification of pro-legalization lobbying organizations (including funding sources, money invested in media campaigns, and tactics used); the consequences of legalization in other states; the impact of popular culture on societal attitudes regarding substance abuse (especially youth); and topics relevant to law enforcement including federal supremacy laws, ballot initiatives vs. legislative action, drugged driving, drug dog programs, arrests, search and seizure, drug free workplace policies, impact on probation and parole, and many others.

3 hours, Friday morning

**Max Mendoza and the 180 Program** – Max Mendoza

The presentation will cover Max's experiences growing up as a troubled youth and his journey through the juvenile justice system. He will share about the struggles he overcame to become successful and what contributing factors helped him to get there. He will also do an overview of the 180 program and the work that they do with the youth of Wyandotte County.

3 hours, Friday morning

**Recognition of the Radical Anti-Government Movement and Sovereign Citizens** – Sarah Viets, Southern Poverty Law Center

Objective is to provide the learner with:

- 1) A working knowledge of the recent history of America's radical anti-government movement, focusing on the philosophies and ideology of the sovereign citizen movement.
- 2) A basic recognition of the current resurgent of the sovereign citizen movement and the potential threat it poses to law enforcement and related fields.

The learner should be able to recognize the most important sovereign symbols, phrases and some of the more common groups and subsets.

Training includes the viewing of a 13-minute roll call DVD on potential threats posed by sovereign citizen movement to law enforcement; in-depth descriptions of sovereign citizen terms, identifiers and beliefs; and a look at organized sovereign groups.

1.5 hours, Friday first session

**Recognition of Domestic Hate Groups** – Sarah Viets, Southern Poverty Law Center

Objective is to provide the learner with:

- 1) A working knowledge of the major domestic hate/extremist groups currently active in the United States and the participants' area of operations.
- 2) Identification of activities of these domestic hate/extremist groups.
- 3) Hate/extremist symbols, tactics and technology.

The learner should be able to recognize the most important groups and subsets, their beliefs and symbols.

Training includes the viewing of several video snippets pertinent to the various categories of domestic hate/extremist groups.

1.5 hours, Friday second session
