## Fall 2017 KACSO Conference Course Descriptions

### **Detox Your Work Environment** – Carmen Rodriguez, *Senior Training Specialist, Cook County Adult Probation*

Do you ever wonder why you feel so exhausted at the end of the work day? Dealing with toxic and difficult people can turn your time at work into a stressful situation. And in your day to day living (at work and at home,) toxic people can make your life a nightmare. You can wind up spending all your energy dealing with issues, resolving problems, and the main culprit: “Toxic People.” Come join us, as we look at fun, insightful and revolutionary strategies to deal with toxic, energy-eating people who simply drain us. This proactive session is designed to help you constructively cope with toxic people.

### **The Real Colors** – Carmen Rodriguez, *Senior Training Specialist, Cook County Adult Probation*

The Real Colors is a personality typing system that enhances communication and the understanding of others. It is important to understand why we do the things we do and why others do what they do. Real Colors Temperament Instrument is grounded in the theory of Carl Jung and validated in the research of Myers-Briggs and Keirsey-Bates. It combines experience and research into an exciting approach that is extremely accurate, understandable and easy to apply in everyday life.

### **Correctional Care Coalition** –Meredith Butler, *Chairperson for Kansas Corrections Care Coalition*, Sally Frey, *Parole & Re-Entry Director*, Andrea Burgess, *Director of Northern Parole Region for KDOC*

Corrections fatigues by definition is described as cumulative negative changes of corrections staff’s personality, health and functioning, and the corrections workplace culture. In the time spent with participants, they will gain insight to assist in identifying components of corrections fatigue and some basic strategies to connect to personal resilience.

### **Emotional Intelligence** – Carmen Rodriguez, *Senior Training Specialist, Cook County Adult Probation*

Emotional Intelligence is the capacity to recognize and effectively manage emotions in ourselves and with others. Emotional intelligence increases our ability to make good decisions, build relationships, deal with stress and cope with change. The ability to deal effectively with our emotions in the work place is critical to our success as we play a vital role in the guidance of those who are placed under our supervision. As the pace of the field increases and our work environment makes more and more demands on our cognitive, emotional and physical resources; emotional intelligence is increasingly critical as a skill set. EI strategies combine with natural intelligence increase our ability to successfully manage the constant challenges by limiting the emotional exhaustion that our job can create.

### **Effects of Impairing Substances** – Rick Heinrich, *Deputy Sheriff at Saline County Sheriff’s Office*

A PowerPoint presentation that will include facts, true stories and examples of effects of marijuana and marijuana edibles. A demonstration activity with marijuana and alcohol goggles to simulate the effects of marijuana and alcohol impairment. Demonstrations will also include “Intoxiclock” showing how long alcohol stays in a person’s body, based on gender, body weight, type of drink, and amount of alcoholic drinks. Other ‘visuals’ will also show marijuana effects.

**Cyber Crime and Social Media** – Ruth Yorke, *United States Probation Officer, District of Kansas*

This workshop will discuss cybercrime, internet, and social media investigations and internet safety. We will cover the supervision of the cyber-offender; ethical use of social media as an investigation tool; basic and advance internet investigations; acceptable use of social media as an employee; and lowering your online profile through settings and privacy tools.

**SASSI 4 Administration and Scoring** – William Ricketts, *Certified National SASSI Trainer, SASSI Institute*

In the Administration & Scoring training, participants will learn how the SASSI was developed, how it should be used, administration & scoring protocols for both the adult (SASSI 4) and the adolescent (SASSI-A2) questionnaires, and will be introduced to the individual scales. Participants will have an opportunity to practice scoring, using the decision rules, and determining if a client may have a mild, moderate, or severe substance use disorder.

**Leadership in Evidence Based Organizations** –Trey Burton, *Chief United States Probation Officer, District of Kansas*

Implementing an evidence-based program doesn't automatically mean you work in an "evidence based organization." Being an Evidence Based Organization means using data to determine policy, guide practice, solve problems, and drive decisions. This workshop will explore leadership core competencies and the major components of how staff and leaders can develop an organization that utilizes evidence based decision making. Items also covered will include: understanding organizational culture, utilization of effective strategic planning, performance measurement, and program evaluation.

**Interstate Compact ICAOS New & Old** – Matt Billinger, *Director Interstate Services, Deputy Compact Administrator, Kansas Department of Corrections*

This training provides the foundation of the compact reminding officers of the purpose and the practice of Interstate Compact. As it is an evolving process, there are always changes. We will also explore new changes that took effect February 2017 to include mandatory retaking, progress reports, and transferring of SB67 DUI convicted person.

**When Law Enforcement Meets Individuals with Autism** – Dr. JoAnn Youngblood, *Child Psychologist, Children Mercy, Kansas City*

Autism Spectrum Disorder is America's fastest growing developmental disability. It now affects 1 in 68 children. Persons with autism are seven times more likely to come into contact with law enforcement than their typical peers. This talk is designed to help professionals understand autism as a neurodevelopmental disorder in regard to communication, behavioral and sensory differences as well as give practical tips to help minimize conflict. This will help law enforcement, first responders and health care professionals when encountering individuals with Autism.

**SASSI 4 Clinical Interpretation Training** – William Ricketts, *Certified National SASSI Trainer, SASSI Institute*

In the clinical interpretation training you will learn the clinical use of the SASSI scales, screening, and assessment information developing the clinical interview, treatment planning issues and how to give feedback to the client. Using numerous profile examples and small group discussion, participants will learn how to differentiate between consistent and inconsistent data given by the client.

**Legislative Updates**-Chris Mechler, *OJA*, Brad Schuh, *Legislative Chair, KACSO Executive Board*

This session will review Kansas legislation enacted in the 2017 Legislative Session and implications for Court Services Officers and the Judicial Branch.

**From Tragedy to Action: A Discussion of One Family's Journey to End Gender and Relationship Violence-** Dr's. Christie & Curt Brungardt, *Co-Founders and Volunteer Director, Jana's Campaign*

This presentation will be delivered by the co-founders of the Hays-based non-profit organization, Jana's Campaign. The single mission of this organization is to reduce gender and relationship violence, In honor of the late Jana Mackey and other victims of gender and relationship violence, Jana's Campaign delivers education programs that prevent domestic and dating violence, sexual violence and stalking. This session will be an overview of these programs.

**2017 Update: New Policy and Solutions for Sentencing in Kansas-** Scott Schultz, *Executive Director, Kansas Sentencing Commission*, Anna Wolf, *Staff Attorney, Kansas Sentencing Commission*, George Ebo Browne, *Research Analyst, Kansas Sentencing Commission*

How did this year's legislative session affect Court Services? This presentation and discussion will explore the changes to criminal law and procedure from the 2017 session. The update will also cover how this policy has shaped recent changes in the statewide presentence investigation reports and felony journal entries. A roundtable discussion is planned to focus on sentencing information CSO's can use and how the Sentencing Commission can provide that support.

**Kansas Offender Registration Act Updates-** John Gauntt, *Manager of Offender Registration Unit, Kansas Bureau of Investigations*

This training provides an overview of the Kansas Offender Registration Act (KORA.) The training begins with what crimes and who are required to register in Kansas. We will then cover the duties of the courts, correctional facilities, law enforcement agencies, the offenders themselves, as well as the KBI. We will discuss what constitutes a violation of the KORA and the consequences of a violation. We will also cover the information available from the registration form and the KBI public website. Lastly, we will look at some frequently asked questions.
